BEYOND WISHES: UNDERSTANDING THE ROLE OF CHILD DEVELOPMENT AND FORENSIC INTERVIEWING IN CUSTODY DETERMINATIONS

In addition to being the most impacted person in the family, Arizona law requires that the Court consider the wishes of a child in custody actions. Recent legislative efforts to establish a set age for children to decide their living arrangements keep being introduced. This presentation will explore the developmental factors that shape a child's ability to participate in legal decision—making and parenting time, as well as the current practices used by forensic interviewers in Arizona to obtain accurate information about the children's wishes from the children themselves. Specific questions that will be addressed include:

- Under what circumstances should the Court listen to the wishes of the child?
- How is a child's opinion properly elicited?
- How to mitigate negative consequences of involving a child in such a decision.
